## UTAH STATE PREPAID SALES TAX PROGRAM

The Utah State Tax Commission has developed a system that provides a simplified method for collecting and remitting sales tax. Independent distributors that sell product for resale within the state of Utah who do not have a sales tax exemption certificate, or meet other exemptions, must participate in prepaid sales tax reporting.

- Sales tax is paid at the time the product is purchased from Nutriex.
- The tax is computed by multiplying the suggested retail price of the product by the sales tax rate at the independent distributor's place of business.
- When products are sold to customers, sales tax is charged.
- All proceeds are retained by the independent distributor because the tax was prepaid.
- The independent distributor is not required to file a sales tax return with the state of Utah for product prepaid under this program.
- Nutriex files a report of sales and remits sales tax to the Utah State Tax Commission.
- The independent distributor may request a refund from Nutriex of prepaid taxes for the product that is sold at a price less than the suggested retail price or returned.
- Independent distributors may not collect any amount of tax in excess of the amount prepaid.

***This agreement is entered into for the purposes of facilitating the collection of sales and use tax on sales by the independent distributors in Utah.*** Nutriex is not obligated to collect any other type of tax including corporate income or franchise tax on behalf of independent distributors.
